C. Packing rate is the same as our moving rate as listed below under heading 4.

2. The following Bulky Article rates will apply:

Spinnet piano- 0-1 floors, origination/ destination combined- \$50.00
Upright piano- 0-1 floors, origination/ destination combined- \$100
Each additional floor for either type adds \$50.00 to total charge, up to a maximum charge of \$300. We reserve the right to refuse a piano move if we deem the move unsafe.

Player pianos, baby grand pianos, organs, no flights of steps- \$200
We reserve the right to refuse a larger piano if steps are involved. Instead, we will refer the customer to a qualified piano mover.

Safe- less than 200 pounds- no additional charge
Safe- 200-400 pounds- \$100.00
Safe- greater than 400 pounds- \$250.00
We reserve the right to refuse the moving of a safe if we deem it unsafe.

Pool table- non-slate- no charge
Pool table- slate, 3 pieces only, disassembled- \$100.00
We do not move single piece slate tables.

Exercise equipment/ treadmill- we do not charge extra for moving exercise equipment. However, home gyms must be disassembled prior to move. If not, we reserve the right to refuse that piece. We do not reassemble home gyms.

Other bulky items- less than 200 pounds- no additional charge.
Other bulky items- 200-400 pounds- \$100.00
Other bulky items- 400-600- \$200.00
Other bulky items- greater than 600 pounds- the Company may refuse the move if we deem the move unsafe.

3. Drive time calculations

Drive time is calculated at our established hourly rate from terminal until return to terminal.



4. Residential moving, packing, and unpacking rates are as follow (calculated per hour): 1

All jobs are charged hourly plus any materials used above as listed under heading 1. The all-inclusive rate does not include the use of dish cells, dish packs, or wardrobe boxes. These items are charged separately.

Hourly rates apply from the time the teams/trucks leave terminal until they return to terminal.

For moves at 75 miles or less each way, we collect a \$100.00 deposit per truck prior to booking each move. This deposit is refunded if our customer gives us a 48-hour notice prior to his/her move. If our customer does not give us 48-hour notice, or if our customer books his/her move less than 48 hours prior to his/her move, we reserve the right to retain this deposit.

For moves greater than 75 miles each way, we collect a \$200.00 deposit per truck prior to booking each move. This deposit is refunded if our customer gives us a 48-hour notice prior to his/her move. If our customer does not give us 48-hour notice, or if our customer books his/her move less than 48 hours prior to his/her move, we reserve the right to retain this deposit.

5. Commercial packing and unpacking rates are as follow (calculated per hour): 2

All jobs are charged hourly plus any materials used above as listed under heading 1.

Hourly rates apply from the time the teams/trucks leave terminal until they return to terminal.

A \$20.00 surcharge is added to all 2-man hourly rates for jobs starting after 5 PM (when later start time is requested by customer).

For moves at 75 miles or less each way, we collect a \$100.00 deposit per truck prior to booking each move. This deposit is refunded if our customer gives us a 48-hour notice prior to his/her move. If our customer does not give us 48-hour notice, or if our customer books his/her move less than 48 hours prior to his/her move, we reserve the right to retain this deposit.


For moves greater than 75 miles each way, we collect a \$200.00 deposit per truck prior to booking each move. This deposit is refunded if our customer gives us a 48-hour notice prior to his/her move. If our customer does not give us 48-hour notice, or if our customer books his/her move less than 48 hours prior to his/her move, we reserve the right to retain this deposit.

6. Surcharges- temporary

Fuel surcharge flat-fee added to each move- \$15.00

7. Liability and Transit Valuation Options: 3

- **Basic Value-** Customer will receive minimal reimbursement, as determined by law, at a rate of \$0.60 per pound of the damaged item, and only that item, due to neglect or mishandling by the mover. There is no charge for this coverage.
- **Depreciated Value Protection-** Customer may purchase this option to cover damages up to the depreciated value of the damaged item, and only that item. Coverage does not extend to sets and matching items. Moves over 75 miles each way hold a \$2.25 per pound minimum declared value. Moves at 75 miles or less each way will be based on the shipper's declared value
CHARGES- \$12.00 per \$1000 declared value.
- **Replacement Value Protection-** Customer may purchase this option to cover damages up to the replacement value of the damaged item, and only that item. Coverage does not extend to sets and matching items. Moves over 75 miles each way hold a \$4.00 per pound minimum declared value. Moves at 75 miles or less



each way will be based on the shipper's declared value. Options with deductibles are listed below.

CHARGES- \$20.00 per \$1000 declared value, \$0 deductible
\$14.00 per \$1000 declared value, \$250.00 deductible
\$9.00 per \$1000 declared value, \$500.00 deductible

Explanation of changes to rates as indicated by superscript highlights-

- 1 Due to higher labor costs for our crew, including the significantly increased cost of health benefits, we have raised our hourly moving rates.
- 2 Due to significantly higher labor rates for our crew, including the increased cost of health benefits, we have raised our hourly moving rates.
- 3 Due to an increase in inland marine and cartage insurance, we are increasing our valuation charges.
