1	<p>Moves and Deliveries</p> <p><i>Hourly Rates</i></p> <ul style="list-style-type: none"> • Residential - \$90 per hour for a 2- member crew and one truck • Commercial - \$105 per hour for a 2-member crew and one truck • Additional crew member, \$25 per hour • 2 hour minimum, • After 2-hour minimum , time is computed in one quarter (1/4) hour increments, rounded to the next higher quarter hour • Charges accrue from arrival time at customer’s residence until unloading at final destination is complete • A one hour travel charge will be added for all jobs within a 30 mile radius of 19664 Mountville Drive Maple Heights, OH 44137. Jobs outside of this radius will be quoted based on above hourly rates derived from estimated travel time. • \$75 per extra stop – An extra stop is when the unit is being loaded or unloaded to an extra stop.
2	<p>Labor Only</p> <p><i>Hourly Rates</i></p> <ul style="list-style-type: none"> • Residential - \$50 per hour for a 2-member crew • Commercial - \$65 per hour for a 2- member crew • 2 hour minimum • After 2-hour minimum , time is computed in one quarter (1/4) hour increments, rounded to the next higher quarter hour • A one hour travel charge will be added for all jobs within a 30 mile radius of 19664 Mountville Drive Maple Heights, OH 44137. Jobs outside of this radius will be quoted based on above hourly rates derived from estimated travel time.
