Spinet piano- If no steps or stairways are involved – No additional charge  
 If steps or stairways are involved - \$50.00 per floor

Upright, Antique, or oversized pianos: \$150.00

Player pianos, baby grand pianos, organs with no steps or stairways involved \$150

We reserve the right to refuse a larger piano if steps are involved.

Grand pianos, No flights of steps - \$250

Big Screens over 48" with no steps or stairways involved, no extra charge. With stairways involved, it is a \$50 charge per floor. Flat screens – no change

Safe – with no steps or stairways involved:

Less than 300 pounds - no additional charge

Safe - 300-400 pounds - \$100.00

Safe - greater than 400 pounds - \$250.00

We reserve the right to refuse a safe move if we deem it unsafe.

Exercise equipment/ treadmill - we do not charge extra for moving exercise equipment. However, home gyms must be disassembled prior to move. If not, we reserve the right to refuse that piece. We do not reassemble home gyms.

Other bulky items less than 400 pounds – deleted.

Other bulky items- 400-600- \$200.00

Other bulky items- greater than 600 pounds - the Company may refuse the move if we deem the move unsafe.

Outdoor play set “Jungle Jims”, swing sets, etc. Company will move only if disassembled completely. An extra charge of \$75 applies. A Four-man minimum and moved with a separate truck applies. Company will not do any assembly. We reserve the right to refuse a play set move.

### **TWO MEN AND A TRUCK® offers three types of coverage**

- 1) Minimal Reimbursement- this coverage is state required by Ohio. This coverage is free with the move. You are only reimbursed at \$.60 per pound per article for anything lost or damaged during the move. No repairs will be offered for this option.
- 2) Depreciated Value Coverage- allows you to declare the total depreciated value of your shipment. If articles are lost or destroyed you are reimbursed the depreciated value of your goods that you declared or \$2.25 per pound per article, whichever is greater.

Option A: This coverage cost \$3.00 per \$1,000 of declared amount. Minimum payment of \$30.00 for up to \$10,000 worth of coverage \$3.00 per \$1,000 after \$10,000 minimum.  
(This option has a deductible of \$100.00)

Option B: This coverage cost \$7.00 per \$1,000 of declared amount. Minimum payment of \$70.00 for up to \$10,000 worth of coverage \$7.00 per \$1,000 after \$10,000 minimum.  
(This option has a deductible of \$0.00)

- 3) Full Replacement Coverage- allows you to declare the total value of your shipment. If articles are lost or destroyed you are reimbursed the full value of your goods that you declared or \$6.00 per pound per article, whichever is greater.

Option A: Minimum payment of \$60.00 for up to \$10,000 worth of coverage. \$6.00 per \$1,000 after \$10,000 minimum. (This Option has a deductible of \$500.00)

Option B: Minimum payment of \$100.00 for up to \$10,000 worth of coverage. \$10.00 per \$1,000 after \$10,000 minimum. (This Option has a deductible of \$0.00)

**TWO MEN AND A TRUCK®** reserves the right to repair or replace any damaged goods at our discretion for options 2 and 3. Any claims must be reported within 60 days of your move date.

### **\*\*\*Declaration of Article(s) of Extraordinary (Unusual) Value\*\*\***

I acknowledge that I have prepared and retained a copy of the "Inventory of Items Valued in Excess of \$100 per pound per article" that are included in my shipment and that I have given a copy of this inventory to the mover's representative.
