Rates

- Hourly rate for complete moving teams.
 - 2 movers and 1 truck \$90 per hour from arrival to completion of move.
 - 3 movers and 1 truck \$120 per hour from arrival to completion of move.
 - 4 movers are 2 trucks \$160 per hour from arrival to completion of move.

- Hourly rate for Labor Only moving teams
 - 1 mover \$30 per hour from arrival to completion of move.
 - 2 movers \$50 per hour from arrival to completion of move.
 - 3 movers \$80 per hour from arrival to completion of move.
 - 4 movers \$110 per hour from arrival to completion of move.



- All moves have a Fuel Surcharge and they are listed as follows:
 - Inside Springfield \$25 per one trip to new location and \$10 added each trip after.
 - Outside of Springfield the miles will be calculated by formula:
(Miles/7mpg= Gallons used) (Price per gallon of current prices X Gallons used) then rounded up to the nearest dollar amount. The total miles of the move are used.

 - Free delivery inside Springfield
 - \$20 delivery charge anywhere outside the city limits
 - Payment is due on delivery of the tubs


