**TRANSPORTATION CHARGES**

Summit Moving & Storage, Inc (dba Starck Executive Relocation, Inc) hereby certifies that it shall provide **binding estimates** for moving services and transportation of household goods that do not include storage. Minimum charge \$380.

Should Summit Moving & Storage, Inc (dba Starck Executive Relocation, Inc) determine that circumstances dictate that we resort to an hourly rate it will be as follows:

- 2 Men and 1 Truck: \$95/hr
- 3 Men and 1 Truck: \$130/hr
- 4 Men and 1 Truck: \$175/hr
- 5 Men and 1 Truck: \$220/hr

(each additional man will be an additional \$45/hr, each additional van will be \$25/hr )

- 2 Men and 2 Trucks: \$120/hr
- 3 Men and 2 Trucks: \$155/hr
- 4 Men and 2 Trucks: \$200/hr
- 5 Men and 2 Trucks: \$245/hr

(each additional man will be an additional \$45/hr, each additional van will be \$25/hr )

VALUATION CHARGES


\$ .60 per pound per item : no charge

Replacement Value/ \$0 Deductible: \$.60 per \$100 of declared value

Replacement Value: \$250 Deductible: \$.50 per \$100 of declared value

Replacement Value: \$500 Deductible: \$.40 per \$100 of declared value

Replacement Value Valuation means that Summit Moving and Storage, Inc. (dba Starck Executive Relocation, Inc.) will, at its sole discretion, replace the item or repair the item to the condition in which it was received for transportation.



## STORAGE CHARGES

Storage Fees are based upon the **actual weight** of the shipment. All rates are per hundred weight (CWT). Minimum pickup charge \$380. Minimum delivery charge \$380. If a move originates further than 50-miles from our warehouse within the State of Ohio, Summit Moving & Storage, Inc (dba Starck Executive Relocation, Inc) will provide a **binding estimate** on the pickup charge (all other charges below will apply). If a move delivers further than 50-miles from our warehouse within the State of Ohio, Summit Moving & Storage, Inc (dba Starck Executive Relocation, Inc) will provide a **binding estimate** on the delivery charge (all other charges below will apply).

Pickup (within 50-mile radius of warehouse): \$10/CWT per month  
Warehouse Handling Into Storage: \$5/CWT (one time fee on arrival)  
Warehouse Handling Out of Storage: \$5/CWT (one time fee on delivery out)  
Delivery (within 50-mile radius of warehouse): \$10/CWT per month

The first bill will be prorated by the day to reflect our billing cycle. Subsequent bills will be prorated by the half-month.

Access to storage prior to delivery out will be billed at \$60/hr.

Valuation coverage for storage is as follows:

Valuation coverage for storage will be the same as the move and will be billed monthly at 10% of the coverage cost for the move. (Ex: Customer declares \$10,000 of coverage for move and selects Replacement Value at \$250 deductible. Valuation cost for the move will be \$50. Monthly charge for valuation during storage will be \$5)
