Tariff Rates

1. Hourly Rates:

- \$108.00 hourly for 2 men with truck
- \$144.00 hourly for 3 men with truck
- \$180.00 hourly for 4 men with truck

- Hourly rates start upon crews arrival at customers home or business until unloaded has been completed and customer releases crew.
- All hourly services require 3 hour minimum
- Rates are charged in 30 minute increments thereafter.


2. Non-Hourly Rates:

If the move exceeds 30 miles from origin to final destination, the following rates apply.

1. Moves will be charged at the rate set forth in item 1 during loading, unloading, packing and unpacking and drive time between origin and final destination
2. Moves exceeding 30 miles from origin to final destination will incur an \$75.00 charge
3. Any additional stops between origin and final destination will incur a \$50.00 charge
4. Non-hourly moves will be charged \$3.00 per mile from unload at final destination until return to office at 4672 Paddock Rd Suite A Cincinnati, OH 45229

3. Miscellaneous Charges:

1. Spinnet or console pianos - \$75.00
2. Full size upright pianos - \$100.00
3. Items weighing 250lbs or more - \$100

Regulations:

1. All items and belongings involved in these charges shall be insured at a value of \$0.60 per pound
2. Particle board and pressboard furniture are not covered.
3. Furniture not properly disassembled is not covered
4. Items not properly boxed are not covered
5. We reserve the right to repair or replace items at our discretion.
6. Liability by carrier shall not exceed the value of damaged items.
7. Consignor or agent shall be present during all services. Liability of carrier is released when consignor or agent is not present.
8. Claims must be submitted in writing within 10 days of completion of service. All claims must include documentation of item value such as purchase receipt or previous insurance estimate.
9. The contents of all desk drawers must be removed. Dresser drawers and other household furniture may contain clothing or light items but not fragile, heavy, valuable items or items containing liquids. All drawers or doors must be secured.
10. Vertical file cabinets may be moved with contents in place. Lateral and security file cabinets must be emptied.
11. All clothing must be in a container.
12. Appliances must be emptied. We will not disconnect or connect any water or gas lines.
